RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks ("Agreement") is made as of the date last written below by and between XIMIAN, INC., a Delaware corporation with its principal executive offices at 401 Park Drive, 3rd Floor West, Boston, MA 02215 (the "Company"), and BATTERY VENTURES VI, L.P., a Delaware limited partnership, as agent, with a principal place of business at 20 William Street, Suite 200, Wellesley, MA 02481 (the "Agent").

WHEREAS, the Company and the Agent entered into a Security Agreement dated February 13, 2003 (the "Security Agreement"), recorded in the U.S. Patent and Trademark Office, pursuant to which the Company granted the Agent a security interest in the trademarks and trademark registrations listed on Schedule I hereto (the "Trademarks"); and

WHEREAS, the Company and the Agent desire to terminate the Security Agreement and to execute and deliver to the Company all deeds, assignments, and other instruments as reasonably may be necessary to revest in the Company full title to the Trademarks, together with the goodwill of the business associated with and symbolized by such Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby relinquishes unto the Company the continuing security interest in and lien on the Trademarks, and otherwise assigns, grants, and conveys to the Company all right, title, and interest in and to said Trademarks and the goodwill of the business associated therewith and any and all rights the Agent may have in or to the Trademarks in order to revest in the Company full title to said Trademarks.

The Agent hereby represents and warrants that it has not assigned any interest in the Trademarks and has the unqualified right to enter into this release and perform its terms.

The Company hereby terminates the appointment of the Agent as the Company's attorney-in-fact.

The Company shall request that the Commissioner of Patents and Trademarks record this document with respect to the Trademarks.
