ASSIGNMENT OF PATENTS AND TRADEMARKS

This Assignment of Patents and Trademarks (this "Assignment") is made as of October 1, 2002 by and between PricewaterhouseCoopers LLP, a Delaware limited liability partnership, PricewaterhouseCoopers Holdings LLC, a Delaware limited liability company, PricewaterhouseCoopers CSG (US) LLC, a Delaware limited liability company, PwC Investments (Florida) LLC, a Delaware limited liability company (formerly named PwCC Holding (Florida) LLC) (collectively, the "Assignors"), and International Business Machines Corporation, a New York corporation (the "Assignee").

RECITALS

A. PricewaterhouseCoopers International Limited and International Business Machines Corporation have entered into the Master Stock and Asset Purchase Agreement dated as of July 30, 2002 (the "Purchase Agreement").

B. Assignors, Assignee and IBM Korea, Inc., a Korean corporation, have entered into the Local Purchase Agreement dated as of the date hereof related to the Purchase Agreement (the "Local Purchase Agreement") pursuant to which Assignors has agreed to sell, transfer and deliver to the Assignee the Acquired Assets of Assignors.

C. Pursuant to Section 2.1 of the Local Purchase Agreement, Assignors desire to assign to Assignee, and Assignee desires to acquire all of Assignors' right, title, and interest in and to all of the Acquired Intellectual Property, including the Intellectual Property listed on Exhibit A hereto, together with the goodwill pertaining thereto (collectively, the "Assigned Intellectual Property").

AGREEMENT

NOW, THEREFORE, in consideration of the foregoing premises, the covenants and agreements contained in the Local Purchase Agreement and in this Assignment, and for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and to implement the assignments of Intellectual Property required by the Purchase Agreement, Assignors hereby agree as follows:

1. Capitalized terms used but not defined in this Assignment shall have the meanings ascribed to such terms in the Local Purchase Agreement.

2. Assignors do hereby sell, transfer, convey, assign, grant, set over and deliver to Assignee, and Assignee hereby accepts, all of Assignors' right, title, and interest in and to the Assigned Intellectual Property, free and clear of all liens, mortgages, options, charges, title defects, security interests and similar encumbrances, the same to be held by Assignee for Assignee's own use and enjoyment, and for the use and enjoyment of Assignee's successors, assigns, designees, nominees and other legal representatives, as fully and entirely as the same

would have been held and enjoyed by Assignors if this Assignment had not been made, together with all causes of action (in law or equity), claims, demands and any other rights for, or arising from any past, present or future infringement, of the Assigned Intellectual Property, along with the right to sue for and collect any damages for the use and benefit of Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives, and, to the extent that any trademark or service mark applications are included in the Assigned Intellectual Property are filed on the basis of Assignor's "intent-to-use" the trademarks or service marks covered by such applications, the portion of the business to which such applications pertains (which business is ongoing and existing).

3. Assignors represent, warrant, and covenant that the execution and delivery of this Assignment does not breach any agreement to which Assignors are a party, and Assignors has not entered into, and will not enter into, any oral or written agreement in conflict with this Assignment.

4. As may be requested by Assignee's or their designees or other legal representatives from time to time after the date hereof, Assignors agree to assist Assignee, or Assignee's successors, assigns, designees, nominees or other legal representatives, in a commercially reasonable manner, without further consideration, to (i) evidence, record, and perfect the assignment of the Assigned Intellectual Property and (ii) secure Assignee's rights in the Assigned Intellectual Property, including, but not limited to, the execution, delivery and filing of all applications, specifications, oaths, assignments, powers-of-attorney, and similar instruments that Assignee deems reasonably necessary to assign and convey to Assignee, or Assignee's successors, assignees, designees, nominees or other legal representatives, all right, title and interest in and to the Assigned Intellectual Property.

5. Assignors hereby authorize and request the United States Patent and Trademark Office whose duty it is to issue, certify, or assign registrations or applications for service marks, trademarks, patents, copyrights, Internet domain names or other evidence or forms of intellectual property protection, to issue, certify or assign as appropriate, the same to Assignee and Assignee's successors, assigns, designees, nominees and other legal representatives in accordance with the terms of this Assignment.






