TRADEMARK ASSIGNMENT

WHEREAS, R. J. The assignment of the Mark is effective as of October 24, 1999. Van Drunen Farms further assigns, transfers, and conveys unto VDF FC, its successors and assigns all right, title, and interest in and to the Registration.

This assignment shall be binding on the successors and assigns of Van Drunen Farms and shall inure to the benefit of the successors and assigns of VDF.
