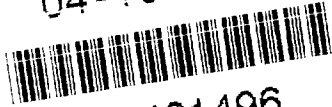

TRADEMARK ASSIGNMENT

WHEREAS, Stan Solomonson ("Solomonson"), an individual with a business address of 23210 Arnold Drive, Sonoma, California 95476, is the record owner of U.S. Trademark Registration No. 2,424,872, issued January 30, 2001, for the mark FUTURE CEUTICALS (the "Mark") covering "dietary and nutritional supplements sold as an integral component of pharmaceutical and nutri-ceutical products," in International Class 5 (the "Registration");

WHEREAS, Solomonson assigned his rights in the Mark and agreed to assign the resulting Registration to R.J. Van Drunen & Sons, Inc., d/b/a Van Drunen Farms ("Van Drunen Farms") on October 19, 1999, and he personally ceased any and all use of the Mark as of October 19, 1999;

WHEREAS, Solomonson wishes to memorialize the terms of the prior assignment of his rights in the Mark and the present assignment of the Registration in a form acceptable for filing with the United States Patent and Trademark Office;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, Solomonson does hereby assign, transfer, and convey unto Van Drunen Farms, its successors and assigns all right, title, and interest in and to the Mark together with the goodwill of the business symbolized by the Mark, and any and all causes of action and rights of recovery for past infringement of the Mark. The assignment of the Mark is effective as of October 19, 1999. Solomonson further assigns, transfers, and conveys unto Van Drunen Farms, its successors and assigns all right, title, and interest in and to the Registration.

Solomonson covenants that he or his representatives will, upon the request Van Drunen Farms, do all other lawful acts necessary to enable Van Drunen Farms to obtain, maintain, and enforce full benefits from the rights and interests herein assigned.

This assignment shall be binding on the successors and assigns of Solomonson and shall inure to the benefit of the successors and assigns of Van Drunen Farms.

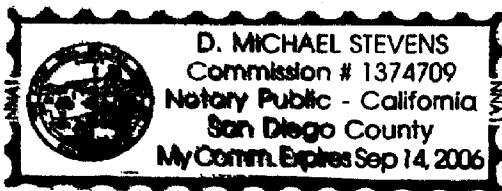
