ASSIGNMENT OF TRADEMARK

THIS ASSIGNMENT OF TRADEMARK (the "Trademark Assignment"), effective as of November 26, 2002, is made and entered into by and between Manco Products, Inc., an Indiana corporation ("Assignor"), and MPI Acquisition, LLC, an Indiana limited liability company ("Assignee"). Capitalized terms used but not otherwise defined herein shall have the meanings given to such terms in the Purchase Agreement (as defined below).

RECITALS

WHEREAS, Arlington Capital, LLC, an Indiana limited liability company ("Arlington"), and Kent J. Rice are the sole members of Assignee;

WHEREAS, Arlington is purchasing certain assets of Assignor pursuant to that certain Asset Purchase Agreement, dated as of November 26, 2002 (the "Purchase Agreement"), by and between Assignor and Arlington;

WHEREAS, by Order dated November 26, 2002, the Bankruptcy Court authorized Assignor to consummate the transactions contemplated by the Purchase Agreement;

WHEREAS, Arlington is transferring, assigning, and conveying to Assignee all of its rights, title, and interest in and to the Purchase Agreement pursuant to that certain Assignment, dated as of November 26, 2002, by and between Assignee and Arlington;

WHEREAS, Assignor has adopted, owns and is using the trademark identified on Schedule A attached hereto (the "Trademark"); and

WHEREAS, Assignor wishes to assign the Trademark to Assignee and Assignee wishes to acquire the entire right, title and interest in and to the Trademark.

AGREEMENT

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby grants, assigns, sells, transfers, quitclaims, conveys, and sets over to Assignee, any and all of its right, title and interest in and to the Trademark, the same to be held and enjoyed by Assignee, for its own use and enjoyment, to have and to hold, for the full duration of all such right, and for the use and enjoyment of its successors and assigns, and other legal representatives as fully and entirely as the same would have been held


and enjoyed by the Assignor, if this assignment had not been made, together with that portion of the goodwill of Assignor's business associated with or symbolized by the Trademark.

This Trademark Assignment shall be governed by, and construed in accordance with, the laws of the State of Indiana, without regard to principles of conflict of laws thereof.

IN WITNESS WHEREOF, the parties hereto have caused this Trademark Assignment to be duly executed as of the date first written above.


