## ASSIGNMENT AGREEMENT

This Assignment Agreement (the "**Agreement**"), made as of August 28, 2003, by and between Sandvik AB, a joint stock company organized under the laws of the Kingdom of Sweden ("**Assignor**") and Minova (USA) Inc., a Delaware corporation ("**Assignee**").

### WITNESSETH:

Whereas Assignor is the owner of the trademarks listed in Schedule A hereto (the "**Trademarks**"); and

Whereas, Sandvik MGT LLC, a Delaware limited liability company and an affiliate of Assignor ("**Sandvik**"), uses the trade names described in Schedule B (the "**Trade Names**") hereto in connection with the operations of Sandvik's division concentrating on specialized chemicals for underground mining (the "**CPD Division**"); and

Whereas Sandvik has agreed to sell and Assignee has agreed to buy certain of the assets of the CPD Division; and

NOW, THEREFORE, in consideration of the above and other valuable consideration, the parties hereto agree as follows:

1. **Assignment Agreement.** Assignor hereby grants, sells, assigns and conveys to Assignee, Assignor's right, title and interest in and to the Trademarks and Trade Names, together with the goodwill symbolized thereby in the United States and all other countries of the world and any and all applications and registrations therefor.

2. **Protection of Trademarks and Trade Names.** Assignor agrees that it will not at any time do or cause to be done any act or thing contesting or in any way impairing or tending to impair any part of Assignee's right, title and interest in the Trademarks and the Trade Names.

3. **Successors and Assigns.** This Agreement shall be binding upon and shall inure to the benefit of the respective successors and assigns of the parties hereto.


