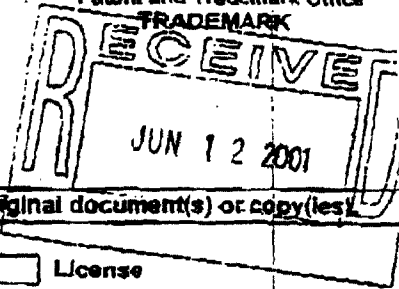

TRADEMARK ASSIGNMENT

THIS ASSIGNMENT is made the 11<sup>th</sup> day of June, 2001 between Otto G. Obermaier, as Receiver for David M. Mobley, Sr., the holder of 99% of the stock in The Heaven Group, L.C. (a Florida Limited Liability Company), and Otto G. Obermaier, in his capacity as Receiver and as transferee of William E. Mobley's 1% of the stock in The Heaven Group, L.C., with the Receiver's principal place of business at 701 Brickell Avenue, Suite 2100, Miami, Florida 33131 (both of Otto G. Obermaier's interests in the foregoing property shall hereinafter be referred to as "Assignor") and Heavenly Cigar Co., Inc. f/k/a Cigar Czar Company, a corporation organized under the laws of Florida with its principal place of business at 3760 Arnold Avenue, Naples, Florida 34104 ("Assignee").

WHEREAS, Assignor has adopted, is using and/or intends to use in the United States the trademarks, and owns the registrations and applications thereof, as listed in Schedule A hereto (the "Marks");

WHEREAS, in furtherance of the transactions contemplated by the agreement entered into on March 19, 2001 between Assignor and Assignee; and

WHEREAS Assignor is desirous of assigning, transferring and conveying to Assignee all of Assignor's right, title and interest in and to the Marks and the goodwill associated therewith; and

WHEREAS Assignee is desirous of acquiring all of Assignor's right, title and interest in and to the Marks and the goodwill associated therewith;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby assigns, transfers, and conveys to Assignee, all of Assignor's right, title and interest, whether statutory or at common law, in and to Assignor's trademarks, trademark registrations and trademark applications set forth on Schedule A, and including the right to sue for past as well as future infringement and to recover pre-assignment damages for past infringements thereof based upon Assignor's trademark rights, and further all the goodwill of the business associated therewith together with the existing and ongoing portion of the business to which the marks pertain.

ASSIGNOR agrees to execute any further papers and to do such other acts as may be necessary and proper to vest full title in and to the Marks and the goodwill of the business symbolized by the Marks, and the registrations and applications thereof.

The Commissioner of Patents and Trademarks of the United States is requested to issue the Certificates of Registration for all pending Marks to the Assignee upon registration.
