GRANT OF SECURITY INTEREST IN TRADEMARKS

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Monster Cable Products, Inc., a California corporation ("Pledgor"), with its principal place of business located at 455 Valley Drive, Brisbane, California 94005, hereby grants to Comerica Bank-California, a California banking corporation, as Agent for Lenders ("Agent"), with an office at 275 Battery Street, Suite 1100, San Francisco, California 94111, a security interest in the following:

(a) All of Pledgor's right, title and interest in and to the trademarks set forth on Exhibit A hereto, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Pledgor connected with and symbolized by such trademarks (collectively referred to as "Trademarks");

(b) Any and all claims for damages by way of past, present and future infringement of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights set forth above;

(c) All licenses or other rights to use of the Trademarks, and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(d) All amendments, renewals and extensions of any of the Trademarks; and

(e) All proceeds and products of the foregoing, including without limitation, all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.


This Agreement is made to secure prompt payment of any and all Obligations and in order to secure prompt performance by Monster Cable Products, Inc. of each of its covenants and duties under the Loan and Security Agreement, dated November 22, 2000, among Monster Cable Products, Inc., Imperial Bank, and Bank One, Arizona, NA (as amended, modified and restated, the "Loan and Security Agreement"). This Agreement has been granted in conjunction with the security interest granted to Agent in the Loan and Security Agreement. The rights and remedies of Agent with respect to the security interest granted herein are without prejudice to, and are in addition to, those set forth in the Loan and Security Agreement, all terms and provisions of which are incorporated herein by reference. Capitalized terms not defined herein shall have the

meanings ascribed to them in the Loan and Security Agreement. In the event that any provisions of this Agreement conflict with the Loan and Security Agreement, the provisions of the Loan and Security Agreement shall govern. This document may be signed in counterparts.


