ASSIGNMENT

This Assignment ("Assignment") is effective as of February 16, 1999 and is entered into by and between **WOLFGANG PUCK FOOD COMPANY, INC.**, a Delaware corporation, having its principal places of business at 1333 Second Street, 1st Floor, Santa Monica, California 90401, as assignor (hereinafter "Assignor") and **WOLFGANG PUCK**, an individual (hereinafter "Assignee").

WHEREAS, Assignor owns certain trademarks and service marks which incorporate the name and/or likeness of Wolfgang Puck including, but not limited to, those listed in **Exhibit A** (collectively referred to as the "Marks"), and is the owner of certain registrations and applications related thereto.

WHEREAS, Assignee is desirous of acquiring the Marks and the registrations and applications related thereto, together with all goodwill associated with the foregoing (the "Intangible Property"); and

WHEREAS, Assignor owns the Intangible Property, and by its execution hereof intends for all of its interest (however designated or documented) in the Intangible Property to be assigned to Assignee;

NOW, THEREFORE, in consideration of the sum of one dollar (\$1.00) and other lawful consideration, the receipt and sufficiency of which is hereby acknowledged, Assignor hereby agrees as follows.

Assignor hereby sells, assigns, and transfers to Assignee, Assignor's entire right, title and interest in and to the Intangible Property in all their forms and for all uses, and including all associated artwork, labels, and package designs, together with the goodwill of the business associated therewith, and any and all past, present and future claims, demands, and causes of action based thereon.

Assignor hereby represents and warrants to Assignee that the undersigned, by its execution below, has the requisite power and authority to assign the Intangible Property to Assignee and that all of Assignor's right, title and interest in such Intangible Property shall be vested in Assignee. Assignor further agrees to cooperate with Assignee and to take all action as may reasonably be required to effect and evidence the Assignment. Without limiting the foregoing, at the request of Assignee, and without further remuneration: (a) Assignor shall execute, acknowledge and deliver to Assignee any and all instruments and documents as may be required by Assignee to establish, evidence and effect the terms of this Assignment worldwide, and to record this Assignment in any country and/or filing location; and (b) Assignor shall cooperate with Assignee in the preparation and prosecution of trademark and service mark applications and registration assignments and renewals worldwide with respect to the Intangible Property.

Assignor hereby irrevocably appoints Assignee, or a designee of Assignee, to act as Assignor's agent and attorney-in-fact to perform all acts necessary to obtain and/or maintain trademarks, service marks, and other rights with respect to the Intangible Property if Assignor (i) refuses or fails to timely perform those acts, or (ii) is unavailable, within the meaning of any applicable laws. Assignor acknowledges that the grant of the foregoing power of attorney is coupled with an interest and shall survive the dissolution, death or disability of Assignor.
