ARTICLES OF AMENDMENT OF
McKESSON GENERAL MEDICAL CORP.

ONE

The name of the corporation (hereinafter called the corporation) is McKesson General Medical Corp.

TWO

The text of the amendment that was adopted is as follows:

Article I of the Amended and Restated Articles of Incorporation of this corporation is amended to be read as follows:

"I.

The name of the corporation is McKesson Medical-Surgical Inc. (the "Corporation")."

THREE

The foregoing amendment was adopted by the corporation's board of directors acting by unanimous written consent on July 18, 2001


FOUR

The amendment was adopted by the corporation's sole stockholder acting by written consent on July 18, 2001
