


ASSIGNMENT OF TRADEMARKS

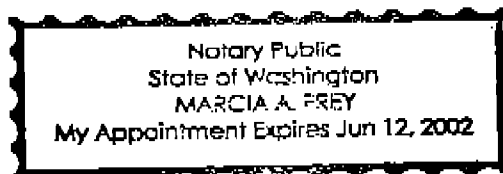


