QUITCLAIM TRADEMARK ASSIGNMENT

WHEREAS, on October 8, 2001, Wixon Fontarome, Inc., a Wisconsin corporation, executed a document purporting to assign all right, title, and interest in U.S. Trademark Registration No. 1,172,773 (the "Trademark") from Fontarome S.A. to Wixon Fontarome, Inc. which document was recorded in the United States Patent and Trademark Office on October 11, 2001, at Reel 2386, Frame 0022;

WHEREAS, the document was signed only by Peter Gottsacker, President of Wixon-Fontarome, Inc. and not by a representative of Fontarome S.A.

WHEREAS, Fontarome S.A. owns all right, title, and interest in the Trademark and all related common law rights, including the goodwill associated therewith, and did not transfer any of its rights in the Trademark to Wixon Fontarome, Inc. by reason of the document executed on October 8, 2001; and

WHEREAS, Wixon Fontarome, Inc. desires to confirm that the document executed on October 8, 2001, was not effective as an assignment of rights in the Trademark and, to the extent that any rights were transferred by the October 8, 2001, document, desires to reassign to Fontarome S.A. all rights throughout the world in and to the Trademark, any applications and registrations therefor, and any common law rights associated therewith, together with the goodwill of the business with which the Trademark has been used and which is symbolized by the Trademark, along with the right to recover damages and profits for past and future infringements thereof.

NOW, THEREFORE, for one dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Wixon Fontarome, Inc. does hereby sell, assign, and transfer unto Fontarome S.A. all its right, title, and interest in and to the Trademark and any applications or registrations therefor, together with all common law rights therein, the goodwill of the business in connection with which the Trademark has been used and which is symbolized by the Trademark, throughout the world, all renewals thereof, and all rights of action, powers, and benefits accrued thereto, including the right to sue for and collect damages and profits for past and future infringements thereof.
