

**TRADEMARK SECURITY RELEASE AGREEMENT**

**THIS TRADEMARK SECURITY RELEASE AGREEMENT** dated as of December 29, 1993 executed and delivered by TRUST COMPANY BANK, as Agent (the "Agent"), in favor of THE HARTWELL COMPANY (f/k/a Hartwell Manufacturing Company, Inc.), a Georgia corporation (the "Owner").

WHEREAS, the Owner and the Grantor entered into that certain Trademark Security Agreement ("Trademark Security Agreement"), dated June 20, 1991 whereby the Owner granted the Agent a security interest in certain Trademark Collateral, associated with the Trademarks (i) "Essentials", Registration Number 1,440,036, (ii) "Eye Stoppers", Registration Number 1,338,033, (iii) "Nitro", Registration Number 1,467,490, and (iv) "White Lightning", Registration Number 1,476,000 (collectively, the "Released Trademarks"), in order to secure the prompt and complete payment, observance and performance of all Secured Obligations under that certain Credit Agreement ("Credit Agreement"), dated June 20, 1991, by and between the Owner and Agent, and recorded in the United States Patent and Trademark Office, Assignment Division at Reel 0806, Frame 0429;

WHEREAS, the Agent and the Owner now agree to release the security interest with respect to the Released Trademarks evidenced in the Trademark Security Agreement;

NOW, THEREFORE, in consideration of the above, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent and the Owner hereby agree as follows:

**Section 1. Release and Reassignment of Security Interest in Trademarks.** The Agent hereby agrees to release and reassign to Owner all rights, title, and interests in the Trademark Collateral associated with and including the Trademarks (i) "Essentials", Registration Number 1,440,036, (ii) "Eye Stoppers", Registration Number 1,338,033, (iii) "Nitro", Registration Number 1,467,490, and (iv) "White Lightning", Registration Number 1,476,000, and including all goodwill connected with and symbolized by the Trademark Collateral obtained pursuant to the Trademark Security Agreement.

**Section 2. Representations.** The Agent hereby represents to the Owner that the Owner has the unqualified right and all due authority to enter into this Agreement and perform its terms.

**Section 3. Binding Effects; Benefits.** This Agreement shall be binding upon the Agent and its successors and assigns, and shall inure to the benefit of the Owner and its successors and assigns.

**Section 4. Governing Law.** This Agreement shall be governed by, and construed in accordance with, the Laws of the State of Georgia.
