

ASSIGNMENT OF INTELLECTUAL PROPERTY

THIS ASSIGNMENT OF INTELLECTUAL PROPERTY is made as of March 19, 2002, by BANK OF AMERICA, N.A. ("Assignor"), for the benefit of TST/Impreso, Inc., a Delaware corporation ("Assignee"), under the following circumstances:

A. Assignee and Assignor have entered into an Asset Purchase Agreement of even date herewith (the "Purchase Agreement") pursuant to which Assignee is purchasing from Assignor all of the right, title and interest of United Computer Supplies, Inc., an Illinois Corporation ("UCS"), United Computer Supplies-East, Inc., a Delaware corporation ("UCSE"), United Computer Rolls Division-East, Inc. Nothing contained herein is intended to expand in any manner whatsoever any of the provisions of the Purchase Agreement, including, without limitation, any of Seller's obligations under the Purchase Agreement. Without limiting the generality of the foregoing, Seller makes absolutely no representations or warranties in connection with such transfer except as expressly and explicitly set forth in Article 3 of the Purchase Agreement.

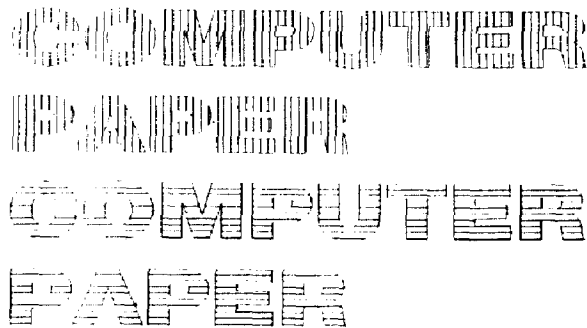
