#### ASSIGNMENT FOR SECURITY

#### **TRADEMARKS**

The Assignor does hereby further acknowledge and affirm that the rights and remedies of the Assignee with respect to the Trademark Collateral are more fully set forth in the Note Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. Capitalized terms used herein and not defined herein shall have their meanings as set forth in the Note Agreement.
