## ASSIGNMENT OF TRADEMARKS

WHEREAS, Pro Mach, Inc., a Delaware corporation ("Pro Mach"), is a party to that certain Second Amended and Restated Credit Agreement of even date herewith (as amended, modified, supplemented or restated from time to time, the "Credit Agreement"), with certain other borrowers, various financial institutions and LaSalle Bank National Association, a national banking association ("Agent");

NOW, THEREFORE, be it known that for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Pro Mach has assigned, and by these presents does hereby sell, transfer, convey and assign, unto Agent the entire right, title and interest of Pro Mach in and to the Trademark Agreement, the U.S.A. Trademarks and other Collateral.
