
WHEREAS, the security interests of the Senior Secured Parties were released in the Release Of Security Interests In Trademarks executed on even date herewith;

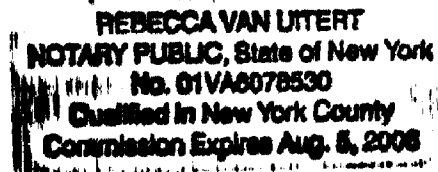
