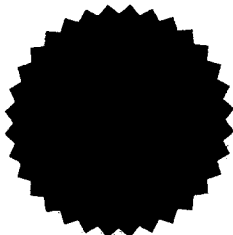

**FOURTH:** The Certificate of Incorporation of the surviving corporation shall be its Certificate of Incorporation.

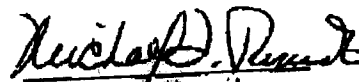
**FIFTH:** The authorized stock and par value of the non-Delaware corporation is 1000 common shares with no par value.
