QUITCLAIM TRADEMARK ASSIGNMENT

THIS QUITCLAIM TRADEMARK ASSIGNMENT is effective as of June 2, 2003.

WHEREAS, JANUS FLOORING CORPORATION, a corporation organized and existing under the laws of Canada, having a principal place of business at 21 Research Road, Toronto, Ontario, Canada M4G 2G7 ("Assignor"), is the owner of certain right, title and interest to the trademark IMAGES and the goodwill associated with the mark (the "IMAGES Mark"), as used in connection with hard wood flooring, and is the owner of U.S. Trademark Application Serial No. 76/362,606 and Canadian Trade Marks Application Serial No. 1124900 for the IMAGES Mark (together, the "Applications"), and;
