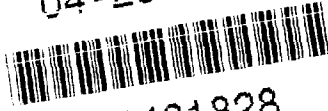


Further, Assignor agrees to do all lawful act, including the execution of documents that may be necessary for obtaining, sustaining or enforcing said application or any registration issuing thereof.
