INTELLECTUAL PROPERTY RIGHTS

Branch hereby releases and assigns unto Riva, effective as of the date hereof, all of its rights, title in and interests and hereby terminates its security interest in the Trademarks and the United States Patent and Trademark Office registrations and applications therefor, including without limitation, any of Branch’s rights, title and interests arising pursuant to the Agreement as recorded with the United States Patent and Trademark Office on June 28, 2002 on Reel 002545, Frame 0533.
