TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of April 3, 2003, by **BANK OF AMERICA, N.A.** having an office at 55 South Lake Avenue, Suite 900, Pasadena, California 91101, as agent ("Agent") for itself and other financial institutions which are parties to the Loan and Security Agreement (as hereinafter defined) in favor of **EFTC Corporation** having its principal place of business at 9351 Grant Street, Sixth Floor, Denver, Colorado 80229 ("Assignor").

WHEREAS, Assignor and RM Electronics, Inc. (the "Borrowers"), and BANK OF AMERICA, N.A., ("Agent") as agent for itself and other financial institutions have entered into a Loan and Security Agreement, dated as of March 30, 2000 (as amended, supplemented, or otherwise modified from time to time, the "Loan and Security Agreement");

WHEREAS, Assignor and Agent have entered into an Intellectual Property Security Agreement, dated as of March 30, 2000 (which Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on August 28, 2000 at Reel 2174, Frame 0920), for the purpose of securing certain obligations of the Assignor to the Agent;

WHEREAS, pursuant to the Loan and Security Agreement and the Intellectual Property Security Agreement, the Assignor granted to the Agent a continuing security interest in and to the Collateral (as defined in the Intellectual Property Security Agreement and collectively known hereinafter as the "Trademarks", including without limitation the Trademarks identified on Exhibit A attached hereto), and pledged, mortgaged, and hypothecated (but did not transfer title to) the Trademarks to the Agent; and

WHEREAS, the Assignor has satisfied all of the Obligations (as defined in the Loan and Security Agreement) and the Agent has agreed to terminate and release its security interest and its right, title and interest in the Trademarks as herein provided;

NOW, THEREFORE, for valuable consideration and pursuant to the terms and conditions set forth in the Loan and Security Agreement and the Intellectual Property Security Agreement:

The Agent hereby terminates and releases its security interest in all of the Assignor's Trademarks, including without limitation the Trademarks identified on Exhibit A attached

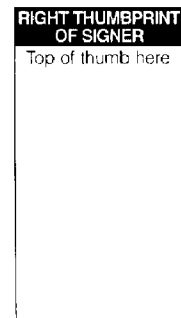
