ASSET PURCHASE AGREEMENT

AGREEMENT made April 16, 2003, between Home-Link Services, Inc., a Delaware corporation, having an office and principal place of business located at 4 Research Drive, Suite 201, Shelton, Connecticut, 06484-6214 ("Seller"), and HomeCard Company, Inc., a Delaware corporation, maintaining an office and principal place of business located at 95-B Rowayton Avenue, Rowayton, Connecticut, 06858 ("Buyer").

RECITALS

WHEREAS, on November 21, 2002, the Seller filed a voluntary petition in bankruptcy under Title 11, Chapter 11, U.S.C. in the United States Bankruptcy Court for the District of Connecticut; Case No. 02-35607 ("Bankruptcy Case"); and

WHEREAS, on March 25, 2003, the Buyer tendered an offer ("Purchase Offer") for the purchase and sale of substantially all of the assets of the Seller's business, including assumption of certain executory contracts, all free and clear of liens, claims, interests and encumbrances; and

WHEREAS, on March 26, 2003, a hearing was held before the Bankruptcy Court at which time the Purchase Offer, as modified by the Buyer's bid, was found to be the highest and best offer; and

WHEREAS, Buyer has completed a due diligence review of the Debtor's assets, books and records; and

WHEREAS, the parties are desirous of embodying herein, the terms and provisions of an Agreement for the sale of substantially all of the remaining assets of the bankruptcy estate as approved by the Bankruptcy Court.

NOW, in consideration of the covenants and agreements contained herein, it is mutually agreed as follows:

1. Sale of Assets: At the "Closing" (as hereinafter defined in Paragraph 7), Seller shall sell and Buyer shall purchase free and clear of all liens, claims, encumbrances and interests, all of the assets owned by the Seller which assets constitute property of the bankruptcy estate under 11 U.S.C. §541, including the assets described in Schedule A attached hereto (collectively, the "Sale Assets") and Schedule B attached hereto sets forth those executory contracts to be assumed by the Buyer (the "Assumed Contracts"); but explicitly exclude each of the assets designated as "Excluded Assets" set forth in Schedule C attached hereto, it being the intent of the parties that the sale include all of the Seller's assets, except those listed on Schedule C.

2. Purchase Price and Adjustments: The purchase price for the Sale Assets (the "Purchase Price") shall be as follows:

- (a) Six Hundred Ten Thousand (\$610,000.00) Dollars to be paid, as follows:
 - (i) One Hundred Thousand (\$100,000.00) Dollars in the form of a Deposit, receipt of which is hereby acknowledged, which Deposit is being held in escrow by Seller's counsel; and
 - (ii) Four Hundred Ninety Thousand Five Hundred (\$490,500.00) Dollars payable to Seller at the Closing in the form of a Cashier's Check, Certified Check or wire transfer; and
 - (iii) Nineteen Thousand Five Hundred (\$19,500.00) Dollars payable to Louis Testa, Escrow Agent by Cashier's check, Certified Check or wire transfer. Said Louis Testa shall hold the escrowed funds for a

period of ninety (90) days pending delivery to Seller by Buyer of up to thirty-nine (39) working laptop computers. Upon delivery of such computers acceptable to Buyer, the Escrow Agent may pay over to the Seller the sum of Five Hundred (\$500.00) Dollars for each computer so delivered. At the expiration of said ninety (90) day period, any sums then remaining in the possession of the Escrow Agent shall be paid over to the Buyer; and

(iv) The \$610,000.00 purchase price reflects a reduction of \$15,000.00 from the Court approved purchase price, being a credit for the absence of certain items of personal property to have been included in the sale, including a display booth.

(b) Assumption of Seller's outstanding post petition Debtor-in-Possession financing liability in an amount not to exceed \$125,013.34, plus accrued interest in the amount of \$4,632.82 as of the date hereof; and

(c) The assumption, at the Closing, of Existing Liabilities as of the date of Closing and all future liabilities pertaining to all executory contracts assumed by Purchaser as more specifically set forth in **Schedule B** attached hereto ("Assumed Contracts"); and


3. Representations by the Seller: The Seller warrants and represents that it is the owner of the Sale Assets and is authorized by the Bankruptcy Court to assign and convey the Sale Assets to the Purchaser subject to the terms and provisions of this Agreement, and that the Sale Assets include all tangible and intangible personal property, including software and intellectual property previously required for the conduct of Seller's business, and that all such assets are complete, working and operational.

The Sale Assets are assigned and sold "as is, where is" and, except for such representations and warranties as are expressly set forth herein, are sold without any warranty or representations by the Seller of any nature whatsoever except as to title.

Seller hereby further represents and warrants as follows:

(a) Due Organization. Seller is a corporation formed under the laws of the State of Delaware, duly organized, validly existing, and in good standing under the laws of the State of Delaware and qualified to do business in such other jurisdiction wherein the nature of its business requires such qualification.

(b) Authorization of Agreement. The execution and delivery of this Agreement and consummation of the transaction contemplated by this Agreement have been duly and validly authorized by all necessary corporate action on the part of Seller, and this Agreement constitutes a valid and legally binding obligation of Seller enforceable according to its terms. The execution and delivery of this Agreement, consummation of the transaction contemplated by this Agreement and compliance by Seller with all the provisions of this Agreement will not (a) violate any provision of the terms of any applicable law, rule, or regulation of any governmental body having jurisdiction; (b) conflict with or result in a breach of any provision of Seller's Certificate of Incorporation or Bylaws or default under any of the terms, conditions, or provisions of, or result in the breach of, or accelerate or permit the acceleration of the performance required by, any note, bond, mortgage, indenture, license, agreement, or other instrument or obligation of any nature whatsoever to which Seller is a party, or (c) violate any order, writ, injunction, decree, statute, rule, or regulation applicable to Seller or any of its property or assets.




(c) Accounts Receivable. Seller is retaining all accounts receivable generated through the date of the Closing except the account receivable owed to it by Home-Link Canada (Royal LePage) and is not selling any other accounts receivable whatsoever pursuant to this Agreement. In the event that the Buyer receives payment on accounts owing to Seller from account debtors of Seller, then such payments shall be turned over to Seller within five (5) days of receipt thereof. Payments on account shall be applied on a first in-first out basis unless designated by invoice. In the event that Seller receives payment on accounts owing to Buyer, Seller shall turn such payments over to Buyer within five (5) days of Seller's receipt thereof.

(d) Schedule B sets forth true, accurate and complete lists of the Assumed Contracts which have been specifically designated for purchase by the Buyer and to which Seller is a party or by which it is bound.

Seller has made available to Buyer the true, accurate and complete copies of the Assumed Contracts. All such Assumed Contracts have been entered into by Seller in the ordinary course of business, and, except for assertions by Home-Link Canada, with regard to those contracts designated in Schedule B, no event has occurred which constitutes, or after notice or the passage of time, or both, would constitute a default by Seller under any Assumed Contract, and, to the knowledge of Seller, no such event has occurred which constitutes or would constitute a default by any other party.

(e) With regard to those contracts as set forth on Schedule B, and except for the assertion of Home-Link Canada and those set forth on Schedule D, Seller is not currently (and at Closing shall not be) subject to any undisputed, non-contingent, liquidated liability under any of the Assumed Contract, in excess of \$5,000.



(f) With regard to those contracts as set forth on Schedule B, and except for the assertion of Home-Link Canada, Seller has received no notice of default and, to the best of Seller's knowledge, is not in material default under any Assumed Contract.

(g) Neither this Agreement nor any schedule, exhibit, statement, list, document, certificate or other information furnished by or on behalf of Seller to Buyer in connection with this Agreement contains or will contain any known untrue statement of a material fact or knowingly omits or will knowingly omit to state a known material fact necessary to make the statements contained herein or therein, in light of the circumstances in which they are made, not misleading.

4. Representations and Warranties of Buyer.

Buyer represents and warrants to Seller that:

(a) Corporate Organization. Buyer is a corporation, duly organized, validly existing and in good standing under the laws of the State of Delaware and is qualified to do business in the State of Connecticut.

(b) Authorization of Agreement. The execution and delivery of this Agreement and the consummation of the transactions contemplated by this Agreement have been duly and validly authorized by all necessary action on the part of Buyer, and this Agreement constitutes a valid and legally binding obligation of Buyer enforceable according to its terms. Neither the execution and delivery of this Agreement, nor the consummation of the transactions contemplated by this Agreement, will violate any provision of the terms of any applicable law, rule, or regulation of any governmental body having jurisdiction or conflict with or result in the breach of any provision of Buyer's Certificate of Organization or Bylaws.



(c) No Adverse Conditions. No legal action is pending or threatened against Buyer that would adversely affect its ability to consummate the transaction contemplated by this Agreement.

(d) No Omission or Misrepresentation. No representation, warranty, or statement of Buyer omits or will omit to state any material fact necessary to make each such representation, warranty, or statement in this Agreement accurate and not misleading in any material respect.

5. Conditions to Buyer's Obligation To Close.

The obligation of Buyer to consummate this Agreement is subject to the satisfaction on or before the Closing Date of the following conditions, unless waived by Buyer.

(a) Entry of an order of the Bankruptcy Court approving this contract and the terms set forth herein;

(b) No Material Inaccuracy. There shall be no material inaccuracy in the representations and warranties of Seller set forth in Section 4 and such representations and warranties shall be true and correct in all material respects as of the Closing Date as though made on and as of that date, and Buyer shall have received a certificate dated the Closing Date from Seller to that effect.

(c) Release of Liens. Seller shall have obtained a release of any and all security interests in the Sale Assets and shall have delivered a Bill of Sale and Assignment in the form of Exhibit I to Buyer assigning and conveying all the Sale Assets free and clear of any and all liens and encumbrances.

(d) No Adverse Proceedings. No action or proceeding against Seller shall have been instituted or threatened that, if successful, could prohibit consummation or require substantial rescission of the transactions contemplated under this Agreement.

(e) Secretary's Certificate. Seller shall have delivered to Buyer a certificate of Seller's Secretary certifying the adoption of resolutions by the Board of Directors of Seller authorizing the execution and delivery of this Agreement and any related documents and instruments to effect the transactions contemplated by this Agreement.

6. Conditions to Seller's Obligation to Close. The obligation of Seller to consummate this Agreement is subject to the satisfaction on or before the Closing Date of the following conditions, unless waived by Seller:

(a) Accurate Representations and Warranties. The representations and warranties of Buyer contained in this Agreement shall be true at and as of the Closing Date, with the same effect as though made at and as of that date except for any changes permitted under the terms of this Agreement, and Seller shall have received from Buyer a certificate dated the Closing Date to that effect.

(b) Payment of Purchase Price. Seller shall have received payment of the Purchase Price of the Sale Assets sold pursuant to this Agreement.

(c) Secretary's Certificate. Buyer shall have delivered to Seller a certificate of Buyer's secretary certifying the adoption of resolutions by the Board of Directors of Buyer authorizing the execution and delivery of this Agreement and any related documents and instruments to effect the transactions contemplated by this Agreement.

7. Closing: The consummation of the sale and purchase of the Sale Assets (the "Closing") shall be held at the offices of Pullman & Comley, LLC, 850 Main Street, Bridgeport,

Connecticut, 06604, on or before April 21, 2003 (the "Scheduled Closing Date"). Each party shall execute and deliver at the Closing all instruments reasonably required to effectuate the terms and conditions of this Agreement and the intent hereof.

8. No Broker: Both parties represent and warrant that all negotiations relative to the Agreement have been carried out by them directly, that each party has been represented by counsel and that no broker brought about the sale of this business.

9. Binding Effect: This Agreement shall be binding upon and inure to the benefit of the parties and their respective legal representatives, successors and assigns.

10. Non-Waiver: No delay of failure by either party to exercise any right hereunder, and no partial or single exercise of any such right, shall constitute a waiver of that or any other right, unless otherwise expressly provided herein.

11. Headings: Headings in this Agreement are for convenience only and shall not be used to interpret or construe its provisions.

12. Governing Law: This Agreement shall be governed by and construed in accordance with the laws of the State of Connecticut. Until such time as the Bankruptcy Case is closed, all disputes arising hereunder shall be adjudicated in the United States Bankruptcy Court for the District of Connecticut, New Haven Division . The prevailing party to any dispute shall be entitled to recovery of reasonable actual attorney's fees and costs.

13. Counterparts: This Agreement may be executed in one (1) or more counterparts, each of which shall be deemed an original, that all of which together shall constitute one and the same instrument.

14. Time of the Essence: Time is of the essence of this Agreement.

15. Entire Agreement: This Agreement supercedes all prior Agreements and constitutes the entire Agreement between the parties with respect to the subject matter hereof.

16. Notices: All notices hereunder shall be in writing and delivered personally, or mailed by certified mail, postage prepaid, addressed to the parties at the following addresses:

Access to Records Until such time as the latter of the Bankruptcy Case being closed or fully administered, the Seller shall have continuing access during normal business hours to any corporate records (including, but not limited to, the financial system software and underlying documents) to be delivered to Buyer in conjunction with this sale and which are reasonably needed and required for completion of the administration of the Bankruptcy Estate, and Buyer shall have access during normal business hours to all records of the Seller reasonably required by the Buyer in conjunction with all assets sold hereunder.






