WHEREAS

The Assignor is the proprietor of the registered Trade Marks set out in the Schedule hereto ("the Trade Marks") and the Assignor has agreed to assign the Trade Marks to the Assignee.

3. The Agreement shall be governed by and construed in accordance with the laws of England and Wales.


