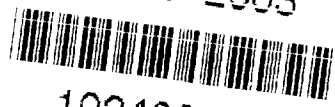

TRADEMARK ASSIGNMENT

3. Assignor acknowledges Assignee's sole ownership of the Trademark and that Assignee is free to use and license the use of the Trademark as he may, in his sole discretion, deem appropriate.
