Pursuant to Section 14-2-1001 of the Georgia Business Corporation Code, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation (the "Articles of Incorporation"):

1.

The name of the corporation is SynQuest, Inc.

2.

The corporation's Third Amended and Restated Articles of Incorporation are amended by removing Article I in its entirety and replacing it with the following:

"Article I.

The name of the corporation (the "Corporation") is Viewlocity, Inc."
