

IT IS HEREBY ORDERED that the Motion is granted under 11 U.S.C. § 362(d)(1) and (2) to the following extent. As it pertains to LINC's interest in the subject property, the automatic stay of 11 U.S.C. § 362 is modified to permit the LINC to obtain possession of the subject

1 property, to dispose of it and to use the proceeds from its disposition to satisfy its claim, all in  
2 accordance with applicable non-bankruptcy law. LINC may seek the appointment of a receiver to

5 Procedure 4001(a)(3) are waived.
