TRADEMARK ASSIGNMENT

This TRADEMARK ASSIGNMENT ("Assignment") is entered into on this 28th day of March 2003, by and between Piedmont Hardwood Flooring, LLC, a Georgia limited liability company formerly known as Piedmont Acquisition, LLC, with a principal place of business at 7702 Industrial Highway, Macon, Georgia 31216 ("Piedmont") and BLC Hardwood Flooring, LLC, a Georgia limited liability company with a principal place of business at Post Office Box 1147, Wadley, Georgia 30477 ("BLC").

WHEREAS, Piedmont is the owner of the entire right, title and interest in and to the following trademarks and the registrations related thereto (collectively the "Marks"):

WHEREAS, Piedmont and BLC have entered into that certain Asset Purchase Agreement dated as of even date herewith (the "Asset Purchase Agreement");

WHEREAS, pursuant to such Asset Purchase Agreement, Piedmont has agreed to sell, assign, and transfer to BLC the entire right, title and interest in and to the Marks, any registrations related thereto, and in and to any renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith;

WHEREAS, the Marks are currently subject to the existing security interests in favor of The CIT Group/Business Credit, Inc. and Harbinger Mezzanine Partners, L.P., which security interests are recorded with the United States Patent and Trademark Office ("USPTO") at Reel/Frame 2213/0369 and 2231/0846, respectively (collectively the "Security Interests");

WHEREAS, the indebtedness secured by the Security Interests has been fully and finally paid and the holders thereof have agreed to release same;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and pursuant to the provisions of the Asset Purchase Agreement, the parties hereto hereby agree as follows:

1. Piedmont does hereby sell, assign and transfer unto BLC, its successors or assigns, the entire right, title and interest in and to the Marks, any registrations related thereto, and in and to any renewals and extensions that may be granted thereon, together with the goodwill of the business connected therewith and any right to recover for past infringement thereof and other past injury thereto.

2. Piedmont agrees to execute such further documents and perform such further acts BLC may reasonably deem necessary, useful or convenient to effect the release of the Security Interests and to record any appropriate releases with the USPTO.
