**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
HILL-ROM MEDAES, INC.**

Pursuant to the provisions of the Georgia Business Corporation Code (the "GBCC"), the undersigned corporation hereby amends its Articles of Incorporation, and for that purpose, submits the following statement:

ARTICLE ONE

The name of the corporation is Hill-Rom MEDAES, Inc.

ARTICLE TWO

The following amendment to the Articles of Incorporation of the Corporation was adopted by the Board of Directors of the Corporation on July 24, 2003:

Article L of the Corporation's Articles of Incorporation is hereby amended by striking Article L thereof and by substituting in lieu of said article the following new Article L:

The name of the corporation is MEDAES, Inc.

ARTICLE THREE

The amendment set forth in Article Two above was adopted by the Board of Directors of the Corporation pursuant to Section 14-2-1002 of the GBCC. Shareholder action was not required.
