NUNC PRO TUNC TRADEMARK ASSIGNMENT

This agreement, dated April 14, 2003 and effective as of August 4, 2000, is made between Reynolds and Reynolds Holdings, Inc., a Delaware corporation, whose principal place of business is 115 South Ludlow, Dayton, Ohio 45402 ("Assignor") and The Relizon Company, a Delaware corporation, whose principal place of business is 220 E. Monument Avenue, Dayton, Ohio 45402, and its related entities ("Assignee").

WHEREAS, Assignor assigned numerous marks to Assignee on August 4, 2000, when Assignee was spun off from Assignor as a separate company;

WHEREAS, Assignee has used the trademark STARTA SYSTEM, which is the subject of Federal Registration No. 1,241,169 (hereinafter the "Trademark"), since such time; and

WHEREAS, the parties agree that the assignment of the Trademark together with the goodwill of the business symbolized by the Trademark, is effective as of August 4, 2000;

THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, effective August 4, 2000, Assignor sells, assigns, transfers, and conveys unto Assignee all right, title, and interest in and to the Trademark and corresponding Registration, together with the goodwill of the business pertaining thereto, and all claims for damages by reason of past infringements of the Trademark, along with the right to sue for and collect such damages for the use and benefit of Assignee and its successors, assigns, and other legal representatives.

This agreement supercedes the agreement dated July 24, 2002, wherein Assignor assigned the Trademark to Assignee ("the July 2002 Assignment"). Both parties agree that the effective date of the July 2002 Assignment was in error.
