trademarks HYDROTAC and PERMATAC, together with the goodwill of the business symbolized by the trademarks, and the aforesaid Registration Nos. 2,204,142 and 2,061,729, and the rights to recover damages for past acts of infringement, nunc pro tunc as of August 7, 1998.
