Release of Lien on Trademarks, Patents and Service Marks

This Release of Lien on Trademarks, Patents and Service Marks (the "Release"), dated as of February 19, 2003, is made by FLEET NATIONAL BANK, a national banking association formerly known as BANKBOSTON, N.A., as agent ("Agent") for the lenders party to the Amended, Restated and Consolidated Credit Agreement, dated as of October 12, 1999, among the AMERICAN SKIING COMPANY ("ASC"), certain subsidiaries of ASC, the lenders party thereto and the Agent, as amended, in favor of ASC UTAH, STEAMBOAT SKI & RESORT CORPORATION and HEAVENLY VALLEY LIMITED PARTNERSHIP (collectively, "Grantors").

WHEREAS, Grantors entered into a Collateral Assignment of Trademarks, Patents and Service Marks (U.S.), dated as of November 12, 1997, pursuant to which Grantors granted to the Agent a security interest in and lien on all right, title and interest of the Grantors in certain trademarks, patents and service marks, including the trademark registrations and applications set forth on Schedule A attached hereto (the "Released Trademarks") to secure the performance of certain obligations (the "Obligations");


