Release of Lien on Trademarks, Patents and Service Marks

This Release of Lien on Trademarks, Patents and Service Marks (the "Release"), dated as of February 19, 2003, is made by FLEET NATIONAL BANK, a national banking association formerly known as BANKBOSTON, N.A., as agent ("Agent") for the lenders party to the Amended, Restated and Consolidated Credit Agreement, dated as of October 12, 1999, among the AMERICAN SKIING COMPANY ("ASC"), certain subsidiaries of ASC, the lenders party thereto and the Agent, as amended, in favor of ASC UTAH, STEAMBOAT SKI & RESORT CORPORATION and HEAVENLY VALLEY LIMITED PARTNERSHIP (collectively, "Grantors").



NOW, THEREFORE, in exchange for good and valuable consideration, the receipt of which is hereby acknowledged, the Agent does hereby release, relinquish and discharge its security interest in, to and under the Released Trademarks.
