TRADEMARK SECURITY AGREEMENT, dated as of September 25, 2003, by each of the entities listed on the signature pages hereof (each a "*Grantor*" and, collectively, the "*Grantors*"), in favor of Credit Suisse First Boston ("*CSFB*"), as collateral agent for the Secured Parties (as defined in the Guarantee and Collateral Agreement) (in such capacity, the "*Collateral Agent*").

W I T N E S S E T H :

WHEREAS, pursuant to the Credit Agreement, dated as of September 25, 2003 (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "*Credit Agreement*"), among Vitality Foodservice, Inc., a Florida corporation (the "*Borrower*"), Vitality Foodservice Canada Co., a Nova Scotia unlimited liability company (the "*Canadian Borrower*"), VFI Holdings Inc., a Delaware corporation, the Lenders (as defined therein), the Issuing Banks (as defined therein), CSFB, as administrative agent (in such capacity, the "*Administrative Agent*") and as Collateral Agent for the Lenders and the Issuing Banks, and Credit Suisse First Boston Toronto Branch, an authorized foreign bank branch named in Schedule III to the Bank Act (Canada), as administrative agent for the Canadian Term Lenders (as defined therein) and as collateral agent for the Lenders and the Issuing Banks, the Lenders and the Issuing Banks have severally agreed to make extensions of credit to the Borrower and the Canadian Borrower upon the terms and subject to the conditions set forth therein; and

WHEREAS, the Grantors are party to an Amended and Restated Guarantee and Collateral Agreement of even date herewith in favor of the Collateral Agent (the "*Guarantee and Collateral Agreement*") pursuant to which the Grantors are required to execute and deliver this Trademark Security Agreement;

NOW, THEREFORE, in consideration of the premises and to induce the Lenders, the Issuing Banks and the Agents to enter into the Credit Agreement and to induce the Lenders and the Issuing Banks to make their respective extensions of credit to the Borrower and the Canadian Borrower thereunder, each Grantor hereby agrees with the Collateral Agent as follows:

Section 1. Defined Terms

Unless otherwise defined herein, terms defined in the Credit Agreement or in the Guarantee and Collateral Agreement and used herein have the meaning given to them in the Credit Agreement or the Guarantee and Collateral Agreement.

Section 2. Grant of Security Interest in Trademark Collateral

Each Grantor, as collateral security for the full, prompt and complete payment and performance when due (whether at stated maturity, by acceleration or otherwise) of the Obligations of such Grantor, hereby mortgages, pledges and hypothecates to the Collateral Agent for the benefit of the Secured Parties, and grants to

the Collateral Agent for the benefit of the Secured Parties a lien on and security interest in, all of its right, title and interest in, to and under the following Collateral of such Grantor (the "*Trademark Collateral*"):

(a) all of its Trademarks and Trademark Licenses to which it is a party, including, without limitation, those referred to on *Schedule I* hereto;

(b) all renewals of the foregoing;

(c) all goodwill of the business connected with the use of, and symbolized by, each Trademark and each Trademark License; and

(d) all Proceeds of the foregoing, including, without limitation, any claim by Grantor against third parties for past, present, future (i) infringement or dilution of any Trademark or Trademark licensed under any Trademark License or (ii) injury to the goodwill associated with any Trademark or any Trademark licensed under any Trademark License.]

Section 3. Guarantee and Collateral Agreement

The security interest granted pursuant to this Trademark Security Agreement is granted in conjunction with the security interest granted to the Collateral Agent pursuant to the Guarantee and Collateral Agreement and each Grantor hereby acknowledges and affirms that the rights and remedies of the Collateral Agent with respect to the security interest in the Trademark Collateral made and granted hereby are more fully set forth in the Guarantee and Collateral Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.


