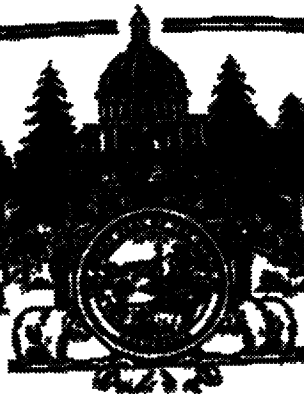

5. This certificate shall become effective on May 1, 2002.

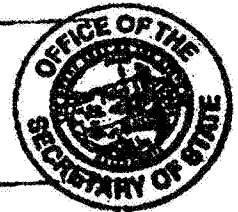
