ASSIGNMENT OF TRADEMARKS

This ASSIGNMENT OF TRADEMARKS (the "Assignment") is made as of May 23, 2003, from Sure-Feed Engineering, Inc., a Florida corporation, (the "Assignor"), to Pitney Bowes Inc., a Delaware corporation (the "Assignee"). Capitalized terms used herein and not otherwise defined have the meaning ascribed to them in the Asset Purchase Agreement (the "Agreement"), dated May 23, 2003, by and between Assignee and Assignor.

WHEREAS, pursuant to the Agreement, the Assignor has agreed to transfer to Assignee all of Assignor's right, title and interest in and to certain trademarks throughout the world that relate or pertain to FLOWMUSTER, filed for use or intended to be used by Assignor (as of the Closing Date) in connection with the FlowMuster Assets (the "Trademarks"); and

WHEREAS, Assignor is the owner of Trademarks which were registered in, and pending applications for Trademarks which were filed with the United States Patent and Trademark Office, as listed on Appendix A attached hereto (the "U.S. Trademarks"); and

WHEREAS, Assignee is desirous of acquiring, any and all rights that Assignor may have in and to the Trademarks and the applications and registrations therefor, together with the good will of the Assignor's business in connection with which the Trademarks are used and which is symbolized by the Trademarks, along with the right to recover for damages and profits for past infringements thereof;

NOW THEREFORE, in consideration of the sum of one dollar and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor DOES HEREBY ASSIGN, TRANSFER AND CONVEY to Assignee, its successors and assigns forever, all of the right, title and interest, whether statutory or common law, of Assignor in, to or arising under the Trademarks, and any and all renewals and extensions of such Trademarks, together with the goodwill of the Assignor's business symbolized by the
