WHEREAS, Assignor has acquired goodwill associated with and symbolized by the Trademarks and the Application and Registration and has not abandoned it;


WHEREAS, Assignee is desirous of acquiring all rights, title, and interest in and to the Trademarks and the Application and Registration owned by Assignor; and


