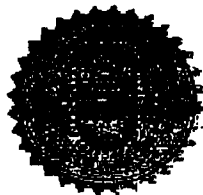

**RESTATED CERTIFICATE OF INCORPORATION
OF
PER-SE TECHNOLOGIES, INC.**

Per-Se Technologies, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the "Corporation"), does hereby certify as follows:

1. The name under which the Corporation originally was incorporated was MDSC Holding, Inc. The date of filing of the Corporation's original Certificate of Incorporation with the Secretary of State of Delaware was November 15, 1985. The Corporation changed its corporate name to Medaphis Corporation on April 28, 1989, and from Medaphis Corporation to Per-Se Technologies, Inc. on August 16, 1999.
2. The provisions of the Corporation's Certificate of Incorporation as heretofore amended, restated and supplemented, which are currently in effect and operative, are hereby integrated into the Restated Certificate of Incorporation hereinafter set forth (the "Restated Certificate").
3. The Restated Certificate was duly adopted by the Board of Directors of the Corporation without a vote of the Corporation's stockholders in accordance with Section 245 of the General Corporation Law of the State of Delaware.
4. The Restated Certificate only restates and integrates and does not further amend the provisions of the Corporation's Certificate of Incorporation as heretofore amended, restated and supplemented, and there is no discrepancy between those provisions and the provisions of the Restated Certificate.
5. The undersigned officer of the Corporation hereby acknowledges that this is the act and deed of the Corporation and that the facts stated herein are true.
6. Effective upon the filing of this instrument with the Secretary of State of Delaware, the Corporation's Certificate of Incorporation as heretofore amended, restated and supplemented, shall be superseded by the Restated Certificate.
