RELEASE OF SECURITY INTEREST

THIS RELEASE OF SECURITY INTEREST made and entered into this ~~30th~~ day of April, 2003, by NATIONAL CITY BANK, as Administrative Agent ("Secured Party"), in favor of FAIRMOUNT MINERALS, LTD., a Delaware corporation (the "Borrower"), BEST SAND CORPORATION, an Ohio corporation ("Best Sand"), BEST SILICA COMPANY, an Ohio corporation ("Best Silica"), PRAIRIE TRANSPORTATION, INC., an Illinois corporation ("Prairie Transportation"), FAIRMOUNT ABRASIVES, INC., an Ohio corporation ("Fairmount Abrasives"), TECHNISAND, INC., a Delaware corporation ("TechniSand"), UNITED WESTERN SUPPLY COMPANY, a Washington corporation ("United Western"), and WEDRON SILICA COMPANY, an Ohio corporation ("Wedron Silica") (Borrower, Best Sand, Best Silica, Prairie Transportation, Fairmount Abrasives, TechniSand, United Western and Wedron Silica are hereinafter collectively referred to as the "Assignors").

WHEREAS, Secured Party and Borrower are parties to a certain Credit Agreement (as amended, restated, modified or supplemented from time to time, the "Credit Agreement") dated as of February 29, 1996, under which the Secured Party extended loans to Borrower and Assignors are parties to a certain Patent, Trademark and Copyright Assignment dated February 29, 1996 (the "Security Agreement"), and recorded in the United States Patent and Trademark Office on April 8, 1996 at Reel 7961, Frame 0066 and July 10, 1997 at Reel 8639, Frame 0218 (Patents) and recorded on April 4, 1996 at Reel 1451, Frame 0909 and July 10, 1997 at Reel 1603, Frame 0167 (Trademarks) under which Assignors granted Secured Party a security interest in certain Patents, Trademarks and Copyrights (as defined in the Security Agreement), including but not limited to the patents and trademark registrations listed in Schedule I attached hereto; and


