

RESOLVED, that the Restated Certificate of Incorporation of the Corporation be amended by changing Article 1 thereof so that, as amended, the Article shall be and read as follows:

- "1. The name of the Corporation is Verizon Services Corp.
The date of filing its original Certificate of Incorporation
with the Secretary of State was October 14, 1983."
