**NOTICE OF RELINQUISHMENT OF SECURITY INTEREST  
IN TRADEMARKS, PATENTS, AND COPYRIGHTS  
(FIRST UNION NATIONAL BANK)**

THIS NOTICE OF RELINQUISHMENT OF SECURITY INTEREST IN TRADEMARKS, PATENTS, AND COPYRIGHTS ("Notice of Relinquishment"), dated as of April 15, 2003, is made in favor of Dan River, Inc. (the "Released Party"), by WACHOVIA BANK, NATIONAL ASSOCIATION (f/k/a FIRST UNION NATIONAL BANK and referred to herein as the "Administrative Agent"), as Administrative Agent for the benefit of the Secured Parties under that certain Credit Agreement dated as of October 14, 1998 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") among Dan River Inc., as borrower, the guarantors named therein, the lenders from time to time party thereto, First Union National Bank, as administrative agent, and others. All defined terms, unless otherwise defined herein, shall have the definitions given to them in the Credit Agreement or the Security Agreement.

**WITNESSETH:**

WHEREAS, pursuant to the Credit Agreement, the Lenders have severally agreed to make Loans and other extensions of credit to the Released Party;

WHEREAS, in connection with the Credit Agreement, the Released Party has executed and delivered a Security Agreement dated as of February 14, 2001 in favor of the Administrative Agent (together with all amendments and modifications, if any, from time to time thereafter made thereto, the "Security Agreement"), and a Notice of Grant of Security Interest in Trademarks dated as of February 14, 2001 ("Notice of Security Agreement in Trademarks") which was recorded with the United States Patent and Trademark Office on or about March 12, 2001 at Reel 2259/Frame 0544; and

WHEREAS, the Administrative Agent has duly authorized the execution, delivery and performance of this Notice of Relinquishment, which purpose is to give notice of the relinquishment of security interest in the Collateral granted in favor of the Administrative Agent, for the benefit of the Secured Parties.


NOW THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged as follows, the Administrative Agent, on its own behalf and on behalf of the Secured Parties, hereby releases and relinquishes the entire security interest in all Collateral, including but not limited to the Collateral listed on Schedule A hereto, and including specifically the Collateral listed in the document recorded with the United States Patent and Trademark Office on or about March 12, 2001 at Reel 2259/Frame 0544. This Notice of Relinquishment may be recorded in the United States Patent and Trademark Office, the United States Copyright Office, and any other administrative office.

This Notice of Relinquishment may be executed in one or more counterparts, each of which will be deemed an original, but all of which together constitute one and the same original.
