

SECOND AMENDED AND RESTATED PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT

THIS SECOND AMENDED AND RESTATED PATENT, TRADEMARK AND COPYRIGHT SECURITY AGREEMENT (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Agreement"), dated as of May 7, 2003, is made by MONARCH LUGGAGE CO. INC., a Delaware corporation ("Monarch"), OCP ACQUISITION CORP., a Delaware corporation to be renamed Bay Travelgear, Inc. ("Travelgear"), BRENTWOOD BAG CORP., a Delaware corporation ("BBC"), and BAY TRAVEL GEAR, INC., a New York corporation ("Bay Travel"); (Monarch, Travelgear, BBC and Bay Travel are sometimes collectively referred to herein as "Grantors" and individually as a "Grantor"), in favor of GENERAL ELECTRIC CAPITAL CORPORATION, a Delaware corporation, as agent (in such capacity, "Agent") for the lenders ("Lenders") from time to time party to the Credit Agreement (as defined below).

RECITALS

- Α. Monarch, Travelgear and Bay Travel are parties to that certain Amended and Restated Credit Agreement dated as of April 19, 2000, as amended by the First Amendment to Credit Agreement dated as of February 14, 2001, the Amended and Restated Forbearance Agreement and Second Amendment to Amended and Restated Credit Agreement dated as of April 26, 2002, and the Third Amendment to Amended and Restated Credit Agreement of even date herewith (such Third Amendment to Amended and Restated Credit Agreement, the "Third Amendment"; such Amended and Restated Credit Agreement as amended by all of the foregoing amendments, the "Existing Credit Agreement"), pursuant to which certain financial accommodations were provided to or for the benefit of such Persons. Prior to the effectiveness of the Third Amendment on the date hereof, the other parties to the Existing Credit Agreement were Fleet National Bank as Administrative Agent (the "Original Agent") and the lender parties party thereto (all such lender parties, the "Original Lenders"). Effective immediately before the effectiveness of the Third Amendment, (i) certain of the Original Lenders sold and assigned all of their respective rights and interests under the Existing Credit Agreement and all of their respective "Loans" (as defined therein) to the Original Lenders who are, as of the date hereof, the Lenders under the Credit Agreement, (ii) Original Agent resigned as Administrative Agent under the Existing Credit Agreement, and (iii) Agent was appointed as successor Administrative Agent under the Existing Credit Agreement (the matters described in the preceding clauses (i)-(iii), the "Lender/Agent Transition").
- In order to secure Monarch's, Travelgear's and Bay Travel's joint and several obligations under the Existing Credit Agreement (including, as to Bay Travel, its obligations as a guarantor pursuant to Article 3 of the Existing Credit Agreement), Monarch, Travelgear and Bay Travel executed and delivered to Original Agent as "Secured Party" thereunder, for the benefit of Original Agent and Original Lenders, that certain Amended and Restated Intellectual Property Security Agreement dated as of April 19, 2000 (such agreement, as amended to date, the "Existing Intellectual Property Security Agreement"). By virtue of the Lender/Agent Transition, Agent is the "Secured Party" under and as defined in the Existing Intellectual Property Security Agreement for the benefit of itself and Lenders.
- In order to further secure the obligations under the Existing Credit Agreement, BBC entered into that certain Nonrecourse Guaranty and Assignment Agreement dated as of February 4, 2000 (such agreement, as amended to date, the "Existing BBC Guaranty") in favor of Original Agent and Original Lenders as "Secured Parties." By virtue of the Lender/Agent Transition, Agent and Lenders are the "Secured Parties" under and as defined in the Existing BBC Guaranty.
- Concurrently herewith, (i) the Existing Credit Agreement is being amended and restated pursuant to that certain Second Amended and Restated Credit Agreement of even date

herewith by and among Grantors, Agent and Lenders (including all annexes, exhibits and schedules thereto, as the same may be amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), and (ii) Bay Travel's guaranty pursuant to Article 3 of the Existing Credit Agreement and the Existing BBC Guaranty are being amended and restated pursuant to that certain Amended and Restated Continuing Guaranty of even date herewith made by BBC and Bay Travel in favor of Agent, for the benefit of Agent and Lenders (as from time to time amended, restated, supplemented or otherwise modified, the "Guaranty"), and under such agreements Agent and Lenders have agreed to make certain financial accommodations to or for the direct or indirect benefit of Grantors, all as more particularly set forth therein.

E. The parties now desire to (i) with respect to Monarch, Travelgear and Bay Travel. continue in effect the Liens originally granted in favor of Original Agent, for the benefit of Original Agent and Original Lenders, under the Existing Intellectual Property Security Agreement, which Liens are (by virtue of the Lender/Agent Transition) now in favor of Agent, for the benefit of itself and Lenders, as set forth herein, and (ii) with respect to BBC, grant to Agent, for the benefit of Agent and Lenders, a continuing Lien on the Intellectual Property Collateral owned by BBC to secure the Obligations. The parties intend that this Agreement amend and restate the Existing Intellectual Property Security Agreement. These Recitals shall be construed as part of this Agreement.

AGREEMENT

NOW, THEREFORE, in consideration of the premises and mutual covenants herein contained and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor and Agent hereby agree as follows:

- <u>Definitions</u>. Unless otherwise defined herein, capitalized terms or matters of construction defined or established in Annex A to the Credit Agreement shall be applied herein as defined or established therein. All other undefined terms contained in this Agreement, unless the context indicates otherwise, shall have the meanings provided for by the Code to the extent the same are used or defined therein.
- Grant of Security Interest in Intellectual Property Collateral. To secure the prompt and complete payment, performance and observance of all of the Obligations, each Grantor hereby grants, assigns, conveys, mortgages, pledges, hypothecates and transfers to Agent, for the benefit of Agent and Lenders, a Lien upon all its right, title and interest in, to and under the following property. whether now owned by or owing to, or hereafter acquired by or arising in favor of, such Grantor (including under any trade names, styles or divisions of such Grantor), and regardless of where located (collectively, the "Intellectual Property Collateral"):
 - all of such Grantor's Patents and Patent Licenses to which it is a party, including those referred to in Part A to Schedule I hereto;
 - all of such Grantor's Trademarks and Trademark Licenses to which it is a party, including those referred to in Part B to Schedule I hereto;
 - all of such Grantor's Copyrights and Copyright Licenses to which it is a (c) party, including those referred to in Part C to Schedule I hereto;
 - (d) all reissues, continuations or extensions of the foregoing;
 - all goodwill, trade secrets, proprietary or confidential information, technical (e) information, procedures, formulae, quality control standards, designs, operating and training manuals, customer lists, and other General Intangibles with respect to the foregoing; and
 - all Proceeds of the foregoing, including (i) any and all proceeds of any insurance, indemnity, warranty or guaranty payable to any Person from time to time with respect to any of the foregoing, (ii) any and all payments (in any form whatsoever) made or

due and payable to any Person from time to time in connection with any requisition, confiscation, condemnation, seizure or forfeiture of all or any part of the foregoing by any Governmental Authority (or any Person acting under color of Governmental Authority), (iii) any claim of any Person against third parties for (A) past, present or future infringement of any Copyright or Copyright License, (B) past, present or future infringement of any Copyright or Copyright License, (C) past, present or future infringement or dilution of any Trademark or Trademark License, or (D) injury to the goodwill associated with any Trademark or Trademark License, (iv) any recoveries by any Person against third parties with respect to any litigation or dispute concerning any of the foregoing, and (v) any and all other amounts from time to time paid or payable under or in connection with any of the foregoing, upon disposition or otherwise.

Without limiting the generality and effectiveness of the foregoing, each of Monarch, Travelgear and Bay Travel hereby reaffirms and continues in effect the respective grants of security interests under the Existing Intellectual Property Security Agreement, all UCC financing statements, and all documents of assignment, perfection, and priority executed and delivered pursuant to the Existing Intellectual Property Security Agreement. The UCC financing statements and all documents of assignment, perfection, and priority executed and delivered pursuant to the Existing Intellectual Property Security Agreement shall continue in effect with respect to the security interests of Agent, for the benefit of Agent and Lenders, in and to the Collateral. Each Grantor agrees that all "Pledged Collateral" (under and as defined in the Existing Intellectual Property Security Agreement) is and shall continue to be security for the Obligations.

- 3. <u>Security Agreement</u>. The Lien granted pursuant to this Agreement is granted in conjunction with the Liens granted to Agent, for the benefit of Agent and Lenders, pursuant to the Second Amended and Restated Security Agreement of even date herewith between Grantors and Agent (as the same may be amended, restated, supplemented or otherwise modified from time to time, the "<u>Security Agreement</u>"). Each Grantor hereby acknowledges and affirms that the rights and remedies of Agent with respect to the Liens granted under this Agreement are more fully set forth in the Security Agreement, the terms and provisions of which are incorporated by reference herein as if fully set forth herein.
- 4. <u>Amendment and Restatement</u>. This Agreement amends and restates in its entirety the Existing Intellectual Property Security Agreement. Neither this Agreement, the Credit Agreement nor any of the other Loan Documents being executed in connection herewith shall constitute an accord and satisfaction or a novation of the obligations evidenced by the Existing Intellectual Property Security Agreement or the other "Loan Documents" (as such term is defined in the Existing Credit Agreement). All obligations under and as defined in the Existing Intellectual Property Security Agreement that remain outstanding as of the Closing Date shall be governed by the terms of this Agreement, the Credit Agreement and the other Loan Documents.
