THIS DEED OF ASSIGNMENT is made the

31 day of DECEMBER

2002

BETWEEN

- (1) EIDOS INTERACTIVE LIMITED a company incorporated in England whose registered office is at Wimbledon Bridge House, 1 Hartfield Road, London SW19 3RU ("Eidos"); and
- (2) EUTECHNYX LIMITED a company incorporated in England whose registered office is at Metro Centre East Business Park, Waterside Drive, Gateshead, Tyne & Wear NE11 9HU ("Eutechnyx").

WHEREAS

- (A) ~~Under an agreement between the parties dated January 17, 2001 (the "2001 Agreement"),~~ Eutechnyx has designed, developed and produced certain computer game software and associated documentation (the "Game") which it licensed to Eidos under the provisional trade name Big Mutha Truckers (the "Trade Name").
- (B) Eidos is the Proprietor of a registered trade mark for the Trade Name (hereinafter called the "Trade Mark"), particulars of which are set out in Schedule 1 hereto.
- (C) Under the 2001 Agreement, clause 13.2 (a), on termination by Eidos by written notice, all rights in the Game other than the Eidos Assets shall be assigned to Eutechnyx.
- (D) Eidos has given notice of termination pursuant to clause 13.2 of the 2001 Agreement to Eutechnyx.
- (E) Pursuant to clause 13.2(a) of the 2001 Agreement Eidos has agreed to assign all such rights, as are not included in the Intellectual Property Rights and the Eidos Assets, in the Game and all associated goodwill in the Trade Name and Trade Mark to Eutechnyx.

NOW IT IS HEREBY AGREED as follows:

1. Save as otherwise expressly provided, the terms defined in the 2001 Agreement shall have the same meaning herein.
2. Eidos hereby assigns to Eutechnyx with full title guarantee the entire right, title and interest in the Trade Name and the Trade Mark and all renewals or extensions of such rights (including all statutory and common law rights and the right to sue for damages and other remedies for past infringements) and all associated goodwill in the Trade Name and Trade Mark for Eutechnyx TO HOLD the same unto itself absolutely.
3. Eidos warrants and undertakes to Eutechnyx that it is entitled to enter into this Deed of Assignment and has not previously assigned rights in or otherwise encumbered the Trade Name or the Trade Mark or granted any licence of rights in the same to any third party and shall not do or purport to do so.
4. Eidos agrees at Eutechnyx' sole cost and expense to execute such further documents and do such further acts as may be necessary or desirable to vest the Trade Mark and the Trade Name in Eutechnyx and to protect, defend and enforce the same.
