

ASSIGNOR hereby declares that the foregoing power is coupled with an interest and as such is irrevocable.

NOW, THEREFORE, for good and valuable consideration the receipt and sufficiency of which is hereby acknowledged, ASSIGNOR assigns to ASSIGNEE all right, title and interest and to the Trademarks and the applications, in the United States together with the common law rights and goodwill of the business symbolized by the Trademarks and together with the right to recover for damages and profits from past infringements thereof, if any.
