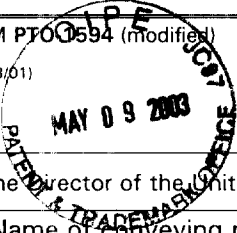

IN WITNESS WHEREOF, the Assignor has executed this Assignment to be effective as of the 16th day of April, 2003.

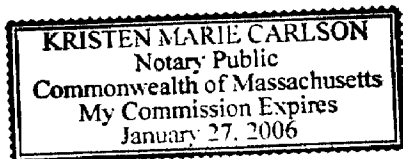
