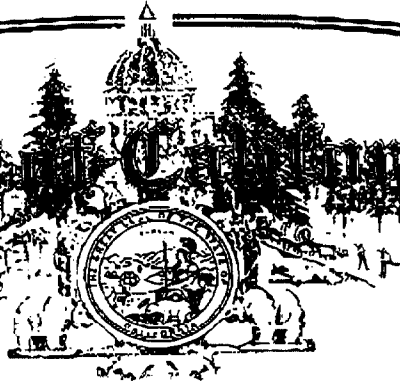

2. Article FIRST of the Articles of Incorporation of this corporation is hereby amended to read in full as follows:


FIRST: The name of this Corporation is BURROWS GOLF, INC.
