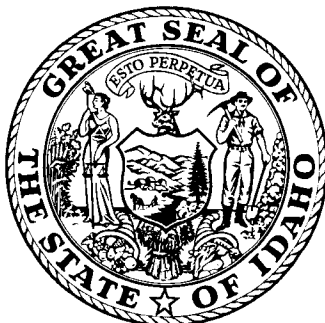

## ARTICLES OF AMENDMENT to the ARTICLES OF INCORPORATION OF ROBISON DISTRIBUTING, INC.

(Hereafter to be known as Robison's, Inc.)

Pursuant to the provisions of the Idaho Business Corporation Act (the "Act"), ROBISON DISTRIBUTING, INC. (the "Corporation"), for the purpose of changing its name to ROBISON'S, INC., adopts the following Articles of Amendment to its Articles of Incorporation:

**FIRST:** The current name of the Corporation is ROBISON DISTRIBUTING, INC. However, the name of the Corporation as amended shall be ROBISON'S, INC.

**SECOND:** The following amendment to the Articles of Incorporation of the Corporation was adopted by the Board of Directors and approved by the Shareholders of the Corporation in the manner prescribed by Section 30-1-1003 of the Act.

### ARTICLE I

The name of this corporation shall be:

ROBISON'S, INC.

**THIRD:** This amendment was adopted by the Shareholders of the Corporation on January 15, 2003.

**FOURTH:** The number of shares of the Corporation outstanding and entitled to vote on this amendment at the time of such adoption was 2,746.0. Prior to the amendment, no shares of any class were entitled to vote as a class. The number of shares voted in favor of such amendment was 2,746.0. The number of shares voted against such amendment was zero.

**FIFTH:** No exchange, reclassification or cancellation of issued shares of the Corporation is effected by this Amendment.
