

TERMINATION OF SECURITY INTEREST

Reference is made to the Trademark Security Agreement (the "Security Agreement"), dated as of February 26, 1993, made by Berg Technology, Inc., a Nevada corporation, now known as FCI (the "Grantor"), in favor of Chemical Bank, a Delaware corporation now known as JPMorgan Chase Bank, as Agent (in such capacity, the "Agent") for the banks and other financial institutions (the "Lenders") parties to the Credit Agreement, dated as of February 26, 1993 (as amended, supplemented or otherwise modified from time to time, the "Credit Agreement") among Berg Electronics, Inc. (the "Borrower"), Berg CS Holdings, Inc., the Lenders and the Agent.

Whereas, pursuant to the Credit Agreement, the Lenders agreed to make loans to and issue letters of credit for the account of the Borrower upon the terms and subject to the conditions set forth therein;

Whereas the Grantor executed and delivered the Security Agreement as a condition precedent to the obligation of the Lenders to make their respective extensions of credit to, and issue letters of credit for the account of the Borrower under the Credit Agreement;

Whereas all amounts outstanding or required to be paid by the Borrower under the Credit Agreement have been paid in full, and

Whereas the Credit Agreement has been terminated, the Agent hereby releases all right, title and interest in and to the security granted to the Lenders by the Grantor under the Security Agreement.


