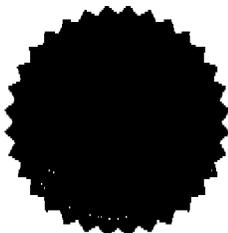

4. Article First of the original Certificate of Formation of this Company is hereby amended to read as follows:

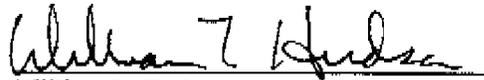
"The name of the company is Certance LLC."

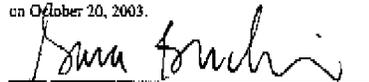
