ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
BWI KARTRIDGPAK CO.

TO: Secretary of State
State of Iowa

Pursuant to the provisions of the Iowa Business Corporation Act of the Iowa Code of 1999, as amended, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

I: The name of the corporation is: BWI KARTRIDGPAK CO. The effective date of its incorporation is February 5, 1901.

II: The following amendment to the Articles of Incorporation was adopted by the Shareholders of the corporation on March 10, 2000, in the manner prescribed by the Iowa Business Corporation Act:

The Articles of Incorporation of BWI KartridgPak Co. be and they hereby are amended to read as follows:

ARTICLE I

The name of the corporation shall be changed and the corporation shall now be known as:

PACKAGING TECHNOLOGIES, INC.

III: The number of shares of the corporation outstanding at the time of the adoption of the foregoing Amendment to Articles of Incorporation was 239,000 shares of Class A common stock, 371,000 shares of Class B common stock, 234,000 shares of Class A Preferred stock and 156,000 shares of Class B Preferred stock. Each share was entitled to vote thereon.

IV: The designation and number of the outstanding shares of each class entitled to vote thereon as a class was none.

V: The number of shares voted for such amendment was 239,000 shares of Class A common stock, 371,000 shares of Class B common stock, 234,000 shares of Class A Preferred stock and 156,000 shares of Class B Preferred stock. The number of shares voted against such amendment was none.
